If an accident occurs, the question of liability shall be between me and the third party involved, if any, and not with the West Michigan Coast Riders and Coyotes MTB Team nor it's sponsors, leaders, or its riders. On occasion transportation to/from practices and/or races may be provided by team leadership. In the event of a traffic accident, the parent/guardian agrees to hold harmless team leaders.

I shall abide by traffic laws, trail rules and regulations and practice courtesy and safety in cycling. In exchange for membership in the organization. I the undersigned, hereby release, discharge, and agree to hold harmless the West Michigan Coast Riders and Coyotes MTB Team, its sponsors, and all of their officers, directors, members, leaders, and all other agents from all claims, demands, anticipated or unanticipated, and resulting from or arising out of, or accident to, the undersigned & his/her dependents participation in this activity, that of its leaders. I agree to wear a helmet.
